

## AL-TAQWA COLLEGE CHILD SAFETY POLICY

All children have a right to be treated fairly. This right was referred to by the Prophet (s.a.w) in the saheeh hadeeth:

"Fear Allah and treat your children fairly" (Narrated by Al-Bukhari, 2447; Muslim, 1623).

## **RATIONALE**

This policy demonstrates the strong commitment of Al-Taqwa College to child safety. It provides an outline of the policies and practices we have developed to keep every child safe from any harm, including abuse.

### **AIMS**

- 1. To embed an organisational culture of child safety, including, parents, volunteers, students, staff and visitors..
- 2. Commit to child safety.
- 3. Ensure there is a code of conduct that establishes clear expectations for appropriate behaviour with children.
- 4. Ensure there is appropriate screening, supervision, training and other human resources practices that reduces the risk of child abuse by new and existing personnel.
- 5. Ensure there are processes for responding to and reporting suspected child abuse.
- 6. Establish strategies to identify and reduce or remove risks of child abuse.
- 7. Establish strategies to promote the participation and empowerment of children.

**IMPLEMENTATION** 

Commitment to child safety

All Al Tagwa students have the right to feel and be safe at all times. The wellbeing and welfare

of our students is our first priority and we have a zero tolerance to child abuse. At Al-Taqwa

College, our goal is to create a child safe and friendly environment where our students feel

safe, have fun and reach their potential.

This commitment applies to all staff, volunteers, parents, our students and individuals

involved in our school community.

Our students' rights to safety and participation

At Al-Tagwa College we encourage our students to express their views, listen to their

suggestions, particularly on matters that directly affect them. We actively encourage all our

students to 'have a say' about things that are important to them.

We teach our students about what they can do if they feel unsafe. We listen to and act on any

concerns reported by our students or detected by our staff, parents, peers and volunteers.

Valuing diversity

At Al-Tagwa College, we value diversity and have a zero tolerance to any discriminatory

practices.

To achieve this we:

• Promote the cultural safety, participation and empowerment of all our students

regardless of their cultural and linguistic background

• Welcome students with disabilities and their families and act to promote their

participation

Seek appropriate staff from diverse cultural backgrounds.

**Recruiting staff and volunteers** 

Al-Taqwa applies the best practice standards in the recruitment and screening of staff and

volunteers. We interview and conduct referee checks on all staff and volunteers and require

Police Checks, Working with Children Check and Statutory Declaration that declares no

criminal offences have been committed.

Our commitment to Child Safety and our screening requirements are included in all advertisements.

## Supporting staff and volunteers

Al-Taqwa's Child Safety Code of Conduct provides guidance to our staff and volunteers on their obligations to child safety, all of whom receive training on the requirements of the Code during induction and biannually.

## Reporting a child safety concern or complaint

All concerns and complaints of staff members need to be reported to the HR Manager. All concerns and complaints regarding student welfare must be reported to the Counselling and Department. Their responsibility includes responding to any complaints made by staff, volunteers, parents or our students. Our reporting processes are outlined in appendix 1. This does not absolve the responsibilities of staff and volunteers of their mandatory reporting obligation (for mandatory procedures please refer to the Mandatory Reporting Policy). Where possible, staff must use all necessary measures to protect any child connected to the alleged child abuse until the investigation process is resolved. The counsellors will follow up with students connected with the alleged incident of child abuse.

# Staff are obligated to report any form of child abuse as per the Education Training and Reform Act.

### Child abuse

- includes any act committed against a child involving
  - o a sexual offence or
  - o an offence under section 49B(2) of the *Crimes Act 1958* (grooming)
- the infliction, on a child, of
  - o physical violence or
  - o serious emotional or psychological harm
- serious neglect of a child.

During an investigation into a child safety concern, any information relating to the incident must be keep strictly confidentially, including information regarding the student or the suspected, parent, staff, volunteer or contractor. Staff failing to adhere to this, may face

disciplinary actions.

**Breaches of the Policy** 

Reporting breaches of unacceptable behaviour

• If a staff, volunteer, contractor, parent or student identifies a breach of conduct then

they need to report this to Human Resources immediately for further investigation.

• Staff are encouraged to fill in a 'Staff Child Safety Incident Report' which is to be given

to the Human Resources Manager

• All incident reports will be kept strictly confidential, however the college reserves the

right to discuss with key child safety committee members

• Human Resources Manager is to keep record of the suspected incident

Risk Management

We apply a safety risk management approach to identify and reduce or remove risks of child

abuse and/or harm. This will inform our policies, procedures and activity planning. In

addition to general occupational health and safety risks, we proactively manage risks of abuse

and/or harm to our students.

**Reviewing this policy** 

This policy will be reviewed annually or sooner if needed. We undertake to seek views,

comments and suggestions from our students, parents, careers, staff and volunteers in

revision of this policy.

## **Child Safety Reporting Process**

Who Can **Staff Member Parent** Child Report or Volunteer Any child safety concerns, including: What to report? disclosure of abuse or harm allegation, suspicion or observation breach of Code of Conduct environmental safety issues Call 000 if a child is in immediate danger How? Face-to-face verbal report, letter, email, telephone call, **HR** (staff complaints) Who to? **Counselling and Welfare Department** (Student Concerns) Parent Liaison (Parent Complaints) The child safety person, manager or supervisor will: What Offer support to the child, the parents, the person who reports happens and the accused staff member or volunteer Initiate internal processes to ensure the safety of the child, clarify the nature of the complaint and commence disciplinary process (if required) Decide, in accordance with legal requirements and duty of care, whether the matter should/must be reported to the police or Child Protection and make report as soon as possible if required. Investigation; outcome decided; relevant staff, volunteers, parents and child notified of outcome of investigation; polices, procedures **Outcome** updated where necessary.
